#### NATURE CONSERVATION ORDINANCE, 1975: DECLARATION OF AREAS AS CONSERVANCIES

Under section 24A(2)(ii) of the Nature Conservation Ordinance, 1975 (Ordinance No. 4 of 1975), I hereby declare the areas, of which the geographic boundaries are set out in Schedules I, II and III, as the SALAMBALA, #KHOADI //HôAS and TORRA Conservancies, respectively.

Maps of the said conservancies shall lie open for inspection during office hours at the offices of the Directorate: Resource Management of the Ministry.

**SCHEDULE II****BOUNDARY DESCRIPTION OF THE #KHOADI//HÔAS CONSERVANCY SITUATED IN THE KHORIXAS DISTRICT, KUNENE REGION**

The point of beginning is the south-western corner of the area known as Hobatere.

From the point of beginning, along the southern boundary of the area known as Hobatere; thence along the northern boundary of the farm Marienhohe 639 to the north-eastern corner of the farm; thence in a general south and south-easterly direction along the boundaries of the farms Marienhohe 639, Qua Vadis 625, Waterbron 623, Condor 617, Emmanuel 613, Deo Volente 610, Anker 602, Katatswa Okonguati 230, Driehoek (no number) and Engelbrecht 272; thence in a general westerly direction along the southern boundaries of the farms Engelbrecht 272, Freyer 671, Brakwater 670, Ruspoort 669 and Suiderkruis 668; thence along the eastern, southern and south-western boundaries of the farm Aandgloed 673 to include the farm; thence along the southern boundary of the farm Avante 672 to include the farm; thence in a general northerly direction along the western boundaries of the farms Tweespruit 272 and Kliprivier 707; thence along the western boundary of the farm Humor 704 to meet up with the veterinary cordon fence, and then along the said fence to the point of beginning.

**SCHEDULE III****BOUNDARY DESCRIPTION OF THE TORRA CONSERVANCY SITUATED IN THE KHORIXAS DISTRICT, KUNENE REGION**

The point of beginning is at the veterinary cordon fence at the most eastern corner of the farm Otjihavera 703.

From the point of beginning in a general southern and south-eastern direction along the boundaries of the farms Otjihavera 703, Spaarwater 711, Palm 708, Nil Desperandum 713, Rooikop 506, Opdraend 718, Vrede 719, De Riet 720 and Mikberg 274; thence in a westerly direction along the southern boundaries of the farms Mikberg 274 and Krone 721; thence from this south-western corner of the farm Krone 721 in a south-westerly direction following the Hoanib river to a point of intersection with the eastern boundary of the Skeleton Coast Park; thence in a northerly direction along the eastern boundary of the Skeleton Coast Park to meet up with veterinary cordon fence at the entrance gate to the Skeleton Coast Park, Springbokwasser, from there in an easterly and then general northerly direction along the said veterinary cordon fence to the point of beginning.
